- 1.1.2 \$120.00 per half day; (up to and including four (4) hrs.)
- 1.1.3 \$180.00 per three-quarter day; (up to and including six (6) hrs.)
- 1.1.4 \$235.00 per full day; (up to and including eight (8) hrs.)
- 1.1.5 \$300.00 per one and one-quarter day; (up to and including ten (10) hrs.)
- 1.1.6 \$355.00 per one and one-half day; (over ten (10) hrs.)
