Mandatory Entry-Level Training (MELT) Program Overview:



Starting March 1, 2019, drivers seeking a Class 1 (tractor-trailer) or Class 2 (bus) license will be required to complete mandatory entry-level training in order to apply for their license. (The 2-S curriculum combines both Class 2 and the School Bus Endorsement "S" requirements needed for the School bus Endorsement "S" requirements needed for school bus drivers). Following training, all students will be required to pass an enhanced knowledge and road test in order to obtain their commercial drivers' license.

Training will include a government-mandated number of training hour's in-class, in-yard and invehicle.

Standardized curriculums must be taught at all licensed Alberta driving schools.

Knowledge and road tests for Class 1 and Class 2 drivers will be expanded to include the new curriculum.

Town of Whitecourt/Woodlands County Annexation

The Town of Whitecourt has been working with the County of Woodlands over the past several years to annex a portion of the County from Flats Road north to the Athabasca River. The annexation will allow for a more logical progression for our municipality's border, using the Athabasca River as a boundary line; and the Town is already the majority property owner.

The language in the document regarding "Flood Plain" could have implications to Northern Gateway – re: assignment of a new school reserve site.

Looking at the "Shaping Whitecourt Map" in the document shows no indication of a new school site other than it is in the Athabasca area (clause said may set aside for school reserve sites).

More discussions need to take place with the Town of Whitecourt regarding this issue.
