Trustees attended sessions on Reconciliation, relationship-building, bullying and corporate citizenship, and shared their learning and suggestions for best practices within governance with the Board.

#### Public School Boards Association (PSBA) Council Meeting Highlights

Board Chair Judy Muir shared highlights from the PSBA's August Council Meeting:

- the PSBA Council commissioned two research papers to be prepared in support of the *Together for Students* campaign last Spring. *One Public K-12 System for Alberta* and *School Division Expenditures* will be shared with public boards and the Government of Alberta in the coming months
- grant money from the former government for the Student Voice Program has run its course. Council members have passed a motion to allocate funds from the Association's unrestricted reserves as seed money to support a Fall 2019 Student Voice Program.

#### Education Act, Ministerial Orders and Regulation Changes

NGPS Superintendent, Kevin Andrea, advised the Board that with the *Education Act* coming into effect September 1, 2019 there will be an associated review of policy and procedures to ensure alignment with legislation. Further discussion and details regarding impact to the division are forthcoming.

#### Mental Health Capacity Building Enhancement Project

The Mental Health Capacity Building Enhancement Project in Onoway and surrounding area has been working in preparation for the 2019-2020 school year. Three success coaches, who will be known as The CREW (Creating Resiliency; Enhancing Wellness), will be supporting students in the east end of the division through this project. #### Supplemental Busing Service Option

Based on requests for additional transportation services, NGPS will consider single, alternate seat placements, for a fee. This alternate seat placement option allows a student to access bus service to/from home, and from one, single alternate address (address other than their home address such as a day home or other service provider).
