- EpiPen there is a requirement that there be one in each school. There was some challenges for bulk orders. If your school division is still having trouble with the bulk orders please provide feedback and talk to other divisions to see what they were able to do. (There was a question about the requirement of the EipPen as one per school would not be sufficient, ie. field trips, and that the costs of obtaining enough and maintaining the EipPens to date are becoming significant. Nathan Freed will bring the concern back to the Education Minister and submit the reply to ASBA.)

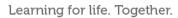
