Ministry approval was sought to move to home schooling in one of our colony schools due to COVID. The administrator there has a strong relationship with the community and knows the kids very well. A lot of work is being done to ensure continuation of learning.

The Administrator's Meeting on March 23 was in-person, and it was great to see everyone. Lots of lively discussion.

Trustees had round table discussion regarding CPR and Naloxone training, and report card format with new curriculum.

The Division's technology department continues to work diligently on system security due to increased cyber activity. Superintendent Bird gave credit to our technicians for keeping up with updates and patches.

We have not been able to fill some teaching positions the Division is looking at hiring full time permanent substitute teachers to fill positions in some communities until permanent teachers can be hired. Round table discussion.
