Use a licensed automobile which carries a valid automobile Third Party Liability insurance as required under Alberta legislation AND a minimum limit of \$2M. Northern Gateway School Division requires that you carry \$2M in order to protect yourself.

Provide the school board with prompt written notice, with particulars, of any accident arising out of the use of a licensed automobile during a trip on board-related business.

Be aware that the school board's Excess Automobile Liability Insurance comes into effect only after the vehicle owner's primary Third Party Liability insured limit has been exhausted.

Be aware that any damage to the volunteer's vehicle, the cost of any insurance deductible or premium Adjustment as the result of an accident while the vehicle is being used on board-related business is NOT covered by the school board's Excess Automobile Liability Insurance.

All drivers transporting students in private vehicles shall provide the Principal/designate with an abstract of their driving record each year during the month of August or more often as deemed appropriate by the Principal/designate.





Approved drivers whose demerits on their operator's license come to a current total greater than six shall be suspended from driving until the demerits are reduced to six or less.

The driver is obligated to notify the Principal/designate immediately, in writing, of any suspension withdrawal, or if the driver's demerits on their operator's license increase to a current total greater than six.

Note:

- All employees of the Board are considered a driver transporting "Passengers for Hire"
- Trustees are considered as acting as an employee and require a Class 4 when transporting students.
