2025 – 26 Board-Directed School Fees

1. 2025 – 26 Board-Directed School Fees

Superintendent Bird presented the proposed 2025 – 26 Board-Directed School Fees to the Trustees for approval. Administration recommended no changes from the current fees. Superintendent Bird answered questions from Trustees regarding cameras on busses and mandated walk distance changes for students. *It was noted that NGPS does not charge fees for grant-eligible students.*

- Grades 1–12 Annual Pass: \$371.00 per student
- ECS Pass (half day): \$185.00 per student
- ECS Pass (full day, every day): \$371.00 per student
- Family Pass: \$927.00 maximum per family
- Replacement Pass: \$6.00 per pass
- Alternate Seat Pass: \$200.00 per student
- Alternate Seat ECS Pass (half day): \$100.00 per student
- Alternate Seat ECS Pass (full day every day): \$200.00 per student
- Alternate Seat Family Pass: \$500.00 maximum per family
