

# Board Policy 7 – Appendix A

## **Trustee Claim Rates**

#### 1. Honoraria

For attendance, Trustees shall be paid an hourly rate of Thirty Dollars (\$30.00) per hour. When attending an overnight/multi-day event, normally Trustees will claim a maximum of twelve (12) hours for each 24-hour conference day.

## 2. Benefit Plans

Eligible Trustees shall be offered a combined Health Spending Account (HSA) and Lifestyle Spending Account (LSA) currently available to Division staff.

#### 3. Travel

- The kilometre rate for Trustees and staff shall be Sixty Cents (\$0.60) per kilometer with an additional Five Cents (\$0.05) per kilometre for carpooling.
- 3.2 Parking fees by receipt.
- 3.3 Taxi fare/car rental by receipt.
- 3.4 Airfare by receipt.
- 3.5 For out-of-province travel, Trustees shall be responsible for transportation claims that are reasonable and cost-effective in consultation with the Board Chair.

Note: Mileage allowance for travel to and from Division Office for Trustees is considered by Canada Customs and Revenue Agency to be a personal benefit and therefore must be included in income as an employment benefit.

#### 4. <u>Accommodation/Lodging</u>

4.1 By receipt.

4.2 In lieu of an accommodation receipt, a private accommodation allowance of Fifty Dollars (\$50.00) per day may be claimed without a receipt.

### 5. Meals

- 5.1 By receipt; or
  - 5.1.1 Breakfast up to Twenty Dollars (\$20.00).
  - 5.1.2 Lunch up to Twenty-five Dollars (\$25.00).
  - 5.1.3 Supper up to Thirty-five Dollars (\$35.00).

Total: Eighty Dollars (\$80.00).

## 6. <u>Additional Honoraria</u>

- 6.1 The Board Chair shall be paid an additional honorarium of Five Thousand, Three Hundred and Fifty Dollars (\$5,350.00) per annum.
- The Committee Chair shall be paid an additional honorarium of Sixty Dollars (\$60.00) per committee meeting.
- 6.3 The Board shall compensate Trustees for internet, cell phone and other technology use to be claimed under a communication allowance, at Seventy-five Dollars (\$75.00) per month.

## 7. <u>Preparation Time</u>

7.1 Trustees shall receive an additional rate of Two Hundred and Forty Dollars (\$240.00) per month for preparation time, only for months in which Board meetings occur.
